RULING

The Court finds in favor of Plaintiff and finds as follows:

Out of the 331 signatures for the Durkin recall that the County Recorder found to be valid, 40 are invalid on the basis of knowingly false circulator affidavits. Thus, the 291 signatures gathered against Durkin fall short of the 293 needed to force a recall election.

Out of the 328 signatures for the Spitzer recall that the County Recorder found to be valid, 43 are invalid on the basis of knowingly false circulator affidavits. Thus, the 285 signatures gathered against Spitzer fall short of the 293 needed to force a recall election.

Another petition sheet for Durkin (containing 8 signatures certified as valid by the County Recorder) and another petition sheet for Spitzer (containing 9 signatures certified as valid by the County Recorder) are invalid because Franco Marzella witnessed at least one signature on each of those sheets yet Hani Saba knowingly signed a false circulator affidavit

indicating he had witnessed all the signatures. That takes the valid signature count to 283 for Durkin and 276 for Spitzer.

Further,

IT IS ORDERED there shall be no recall election as to Mike Durkin and Charlie Spitzer.

IT IS FURTHER ORDERED enjoining Town of Cave Creek Arizona, Board of Supervisors of Maricopa County and Helen Purcell from taking any further action to conduct a recall election.

IT IS FURTHER ORDERED signing this minute entry as a final appealable written Order of the Court. The Court notes that no further matters remain pending and this order is entered pursuant to Rule 54(c).
