Most of you know by now that we are in a recall election for the Council seats in Cave Creek. This is not a surprise to many of our readers, inasmuch as the Sonoran News and some of the current new candidates announced to the public the very same night of the June 2013 election that they would pursue a recall election at the earliest opportunity. Arizona laws provided the time lines for such elections, and right on schedule, the battle was engaged months ago. The same law requires as well a showing of abuse of office, which could hardly be alleged on election night.

One could hardly pick up a copy of the Sonoran news since June 2013 without a discussion by editor or guests as to the intentions of warfare to come. I am advised by town staff that the approximate cost to you, the taxpayers, will be about \$30,000, just for the basic costs of filings, and regulation enforcement.

The first attempts failed for improper signatures, per two different court opinions. But now we are in the real deal. We at the Chronicle will make a genuine attempt to provide you with honest reporting. So far, there have been no public forums, but we will advise you of same as made known. That leaves our attention to some necessary correction of Big Fibs, or at best, careless presentation of information by the Sonoran News candidates.

One such very big story has alarmed many citizens, namely that the Town was cutting off Rancho Manana water supply, and worse. John will first introduce you to the main issue, namely the private deals cut by Usama for cheap water for favored customers, while raising most users' rates;

The Sorchych Slates Big Stink

As so often is the case with Sonoran News' outlandish, sensationalized and fabricated headlines, their December 17, 2014 front page story 'Prinzhorn to Cut off Water supply to Rancho Manana Golf Course', is yet another example of a half-baked, non-existent and fabricated crisis, creating Cave Creeks' very own WATERGATE conspiracy.

This supposed crisis was initiated out of the Water Advisory Committee (WAC) review of a number of agreements and contracts signed by the former Town Manager and Rancho Manana principals. There were no directives issued, no decisions were made and no corrective actions were proposed. The WAC meeting(s) are to review and make recommendations.

Important to Know:

Recall Was Decided Early On:

The word "recall" was first publicly used as early as the night the Councilmen were sworn in (6/3/2013). Then, mention of a "recall" began appearing in print only 23 days (6/26/2013) after taking their seats on the Council. How can four men each merit recall after only 3 weeks in office?

Twisted Facts:

In order to support their recall mission, the opposition began "Spinning" (twisting) the facts immediately after the Councilmen took office, as evidenced by repeated editorials and letters to the editor in the local paper. In this way, the public was denied the facts.

NOT a Slate:

Durkin, Monachino, Spitzer and Trenk are NOT a slate, only four men who stood up to the plate for their community. On agenda items, their opinions vary and they always vote their own mind. Their votes are a reflection of their research and personal opinions as well as those of their constituents.


Let's be very clear what the March 10th election is all about. For close to ten years, major decisions concerning the town were influenced by two people – the editor of a local paper and the former Town Manager. Cave Creek Council members quickly learned that the best way to retain their seat on the Council was to garner positive press, and the best way to accomplish that was to do what the editor of the local paper wanted done. So to assure themselves an almost guaranteed retention of their Council seat in subsequent elections, many Council people abrogated their decision-making authority and allowed the Town Manager and the editor to control the town's agenda.

With the election of Mike Durkin, Reg Monachino, Charlie Spitzer, and Adam Trenk to the Council in June of 2013, those two people no longer have influence in Town Hall. The Council replaced the Town Manager, whose power, authority, and actions far exceeded the scope of his position. They awarded the contract for town advertisements to a paper other than the one that continues to berate and disparage citizens and Council members alike. Since Durkin, Monachino, Spitzer and Trenk can't be controlled, manipulated or humiliated into submission by the local paper, supporters of the editor want them removed from office – a recall. It's as simple as that.

This recall is not about performance; a recall was threatened before Council members even took the oath of office. This recall is about power, and whether Cave Creek will be governed by duly-seated elected officials or outside influences and favor.



MUSICFEST / GRAMMY NOMINEES TO PERFORM AT ARIZONA MUSICFEST IN NORTH SCOTTSDALE

For 24 years, Arizona Musicfest has brought the best and brightest musical artists to Arizona, and soon venues in and around North Scottsdale will host multiple 2015 GRAMMY nominees as part of this year's Festival. Headlining the month-long series of concerts is Rosanne Cash, who will be performing February 20 at Highlands Church. The thirteen-time GRAMMY nominee has followed in the footsteps of her legendary father, Johnny Cash, extending the country genre to appeal to an even wider appreciative audience. The Orchestra will also be front and center as the sultry songbird, Storm Large, lead singer of the sensational group Pink Martini, joins them to perform songs from the Great American Songbook on February 27 at Highlands Church.

"It's such a thrill to have these incredible artists, clamoring to join us, excited to share their music with our appreciative Arizona Musicfest audiences. I can't wait to take the podium."
