#### CASE RESULTS:

Late , but still useful, was the draft finding of the Court, that the lawsuit against the previous council members was not based on law! Just made available to us was the following document:

Superior Court of Arizona Case CV-2013-011198/ Honorable Douglas Gerlach Usama Abujbarah v. Town of Cave Creek.

Regarding alleged conspiracy of officials to terminate Abujbarah, before they were sworn officials.

The following draft ruling was published on 3-16-2015 (excerpt): "Contrary to what the Abujbarah response suggests (at 5), the directive to construe the Open Meetings Law broadly in favor of open meetings is not license for a court to assume that the Legislature must have intended to include members-elect within the scope of that law, and then issue a ruling as if the legislature had done so"

(Translate: The Open Meetings Law intended to punish officials who breached this law by communicating with each other secretly and not in open session with the public, but DID NOT INTEND THIS TO APPLY TO ANY PERSONS WHO WERE NOT YET ELECTED/SWORN IN AS OFFICIALS.) The actual ruling: IT IS ORDERED:

**1**. The Defendants' motion for partial reconsideration is granted.

2. The Defendants' (new councilmen in 2013) cross –motion for summary judgment is granted in part. Plaintiff's (Usama) claim is denied to the extent that it is based on a violation of ARS §38-431.01 (open meetings law) having been committed by discussions that may have taken place among persons who were newly-elected to the Cave Creek Town Council before the assumed their offices.

Dare we hope that this \$3,000,000 cloud will be removed?? The judge must make this a final ruling for that.

#### GUEST EDITORIAL - It's Déjà Vu All Over Again – Ray Stark

My suggestion to everyone who voted for the new council: Stay involved! Keep track of what your elected representatives do to further enhance and secure the character and financial health of our unique town. Government is not an autonomous machine. It requires active involvement by the electorate: Stay involved or prepare to be disappointed. Government, by its very nature, runs amok if left unattended.

The new council members should be thanked for their willingness to volunteer for public service. Having served for 16 years as a director on a homeowner's board, I understand all too well how thankless public service can be. Just remember, while you won't make everyone happy, you will be held accountable for your actions.

It has been said time and again, "Votes Have Consequences." Let's hope the new council uses good advice and deliberates long and hard using the best leadership possible, always putting what is best for the town ahead of any personal benefit or benefit to a minority. That must be the "gold standard" under which every decision is made.

The decisions before this council are daunting. So that we all understand how we got here, let's look at a few essential facts...

Eight years ago an ambitious, but unqualified, town manager decided Cave Creek needed to become a public utility. Using flawed analytical data and over-optimistic projections, he sold our mayor, council, and voters, on buying not one, but *two* water companies. The town of Cave Creek bought Cave Creek Water Company for 20.1 million dollars (17.5 million for the company and 2 million in cash for improvements.) This company had sold only the year prior for *2.4 million dollars*.

Immediately after this purchase, the Town announced they were merging Cave Creek Water Company into the Desert Hills Water Company as well as building a water treatment plant. In 2005 the citizens of Cave Creek approved a maximum of 50 million dollars in WIFA loans to fund water infrastructure improvements. By August of 2007, the Cave Creek WIFA loan debt had reached 65.9 million dollars.

The costs for the water companies and waste treatment plant mounted through 2008 while other revenue for the town decreased. The Arizona Republic reported Cave Creek's budget shortfall for 2009 was 5.7 million dollars. The town of Cave Creek nearly went bankrupt that year.

*Bankrupt.* All because of bad decisions backed up by bad assumptions that were not uncovered by any public discussion or vetting. Many of these decisions were made behind closed doors.

One of the new council members (Esser) was on the council then and voted for the water company purchase. Another one of the new council (Lamar) was on a town planning commission and is on record enthusiastically supporting this move. Enough history.

This town was pushed right to the very brink of insolvency by poor leadership, extremely poor decisionmaking, and subterfuge in trying to conceal the true costs of being a public utility from the citizens of this town. We dodged a very large bullet back then. *We almost ceased to be.* 

As a result of these decisions, Cave Creek now pays 4.8 million dollars in debt service on our loans each year as we will for another decade. Additionally, because we allowed an unqualified and inept town manager to supervise a waste treatment plant that was, vastly oversized, poorly engineered, poorly constructed, and judged defective shortly after it started up, we have had to subsidize its operation every year. Last year the

waste treatment plant cost the citizens of Cave Creek 1.2 million dollars because it is only running at 30% of capacity. That's totals six million dollars a year out of a budget of only 16.5 million, over a third of our total budget. And budget projections for next year are not good. Some estimates indicate that revenues may drop by over a million dollars or more. Our income will decrease –but our debt won't.

## What does *that* mean? It means this new council is going to have to pull a rabbit out of a hat.

With less money coming in, a huge debt payment every year, and ever-escalating costs on the water company, this council is going to have to either cut expenses somewhere, or raise revenue.

I am a "road guy." After managing my community's roads for 16 years, I was stunned when I moved to Cave Creek and really examined the quality of the roads. They are appalling and the road survey echoed that very clearly. The problem is, we don't have the money to repair them because we have too much debt and too low an income stream. No repaying has been done in town in the last eight years except on Cave Creek Road and the few times where the wash ate the roadway on School House and Spur Cross.

The engineering analysis (Pavement Management Program) done for the town last summer indicated many of our streets were past the point of repair and needed to be replaced. The further a road is allowed to fail, the more costly it becomes to replace the roadway.

They say you can tell the financial health of a town or city by looking at its roads. Remember that as you travel around the town over alligator cracked and crumbling town streets. Our streets stand as a monument to the crippling debt we now bear resulting from the poor choices made after we got into the water business. I suspect the Sonoran News will try to blame the last council who served for a scant 20 months for the predicament faced by our town. The honest truth is this problem began with the huge debt our town took on and now those who supported and encouraged that debt are back in power. If this same group makes one more financial screw up, Cave Creek may find itself facing three unpleasant choices:

- 1. Bankruptcy or insolvency
- 2. A substantial property tax to avoid bankruptcy which the voters will likely reject as they have in the past –and vastly higher sewer and water rates!!!
- **3.** Annexation by a neighboring city, Phoenix perhaps, as a court-ordered solution in the re-organization process -which we may have very little say in

Of the choices above, we nearly triggered # 1 in 2008. With declining revenues and unrelenting debt we could be there again in short order. The council will try to push option #2 but again, as they always do, the voters will reject it. That leaves us facing option #3. How will that affect our unique lifestyle? I am a new Cave Creek resident. After living just east of Carefree for nearly 20 years, I moved here because of the unique character that Cave Creek offers. I want to see my town thrive, prosper and flourish while managing the inevitable change without destroying this character. Far and away the biggest threat we face today is financial.

Those who contributed to our financial concerns are now back in power, aided directly in their campaign efforts by the Sonoran News. If you doubt Don Sorchych wants to exert vast influence over town operations, merely look at the last Sonoran News with his list of recommendations. One of those recommendations is to do away with our Planning and Zoning commission and our Water Advisory Committee. They did away with the Water Committee once before, despite the state mandate to maintain one.

Just between two of the WAC members, we have 60 years of water production and distribution experience. We couldn't afford these two individuals if we had to pay them for their considerable expertise. Yet they willingly volunteer their expertise freely. How can this be a bad thing, especially when water is quickly

becoming a HUGE issue in this state? When you have to make a tough decision, would you like to have more expert opinion to base your decision on or less?

Or, let me put it another way: Who do YOU want making critical decisions about your ability to access to water in our community: An expert with decades of experience or an 85 year-old newspaper editor? You would be willing to forgo that expertise offered by our incredibly talented volunteers for one simple reason: CONSOLIDATION OF POWER. Wasn't a lack of expertise and good outside advice the leading cause of the horrible decisions that put Cave Creek in the financial position it finds itself in today? And Don Sorchych wants us to go back to that inarguably flawed process again? Councilman elect Esser is on the record as having stated, "We just need to go back to the way we were."

Can we really afford to? Do you want to? The voters in this recall apparently do. Don't turn your backs on town government now. Stay involved and stay aware. Or, this last holdout of the American West may go the



way of the Pony Express. Remember, we nearly went insolvent 6 years ago... This town has a habit of repeating things that turn out *badly*. Get your neighbors and friends involved and aware so that it doesn't happen again!

## Update on 2014/2015 Roadway Maintenance Activities from The Town Engineer

Since mid-summer last year, the Town of Cave Creek has performed the following roadway maintenance and repairs as outlined in the Town's Pavement Management Plan:

- 1. Milling and new Pavement Overlay of 44,290 square yards of Cave Creek Road and Carefree Highway (near Wal-Mart).
- 2. Seal Coating of 27,750 square yards on a various Town roadways.

In the upcoming weeks (before July 1<sup>st</sup>), we will finalize this year's roadway maintenance activities by completing the following projects that we began scheduling several weeks ago:

- 1. Seal Coating of 26,720 square yards on a variety of Town roadways.
- 2. Chip Sealing 11,250 square yards of several other Town roadways.
- 3. Pavement Striping of Schoolhouse Road and Fleming Springs Road.
- 4. Performing pavement repairs to 11 additional Town roadways.

It is important to note that we have placed the Pavement Management Plan on the Town's Website for your information. This document identifies all of the major roadway repair activities for a five-year period (2015 to 2019).

The budget for next fiscal year's roadway maintenance activities is currently being prepared. For next year, we will again follow the Pavement Management Plan project listing which identifies the roadways most in need of repair and maintenance.

If your roadway is not shown in the plan, it does not mean that it will never be maintained, it simply means that it is not listed in the current five-year plan. Every five-years the plan is updated, so your roadway may be in the next five-year cycle.

In summary, by July 1<sup>st</sup>, we will have completed all of the roadways listed in the Pavement Management Plan for 2015, <u>a total of nearly one million square feet of pavement surfaces</u>.

Next year, more pavement maintenance work on Cave Creek Road from Spur Cross Road south to the Town of Carefree border will take place as well as fifty other roadway sections identified in the Pavement Management Plan. 3-17-15

On March 17<sup>th</sup>, 2015 the Town of Cave Creek will be opening a new 70 space public parking lot on North Hidden Valley Drive one block south of Cave Creek Road. Signs have been placed along Cave Creek Road to provide direction for visitors and patrons of our local establishments.

There are no fees to park in this parking lot and it was situated to provide easy walking access to the many fine shops and restaurants located along Cave Creek Road. Additionally, parking for parades and other special events will now be easier for our out-of-town guests.
