Featured Artist Of The Week: Jan Stiles, Jewelry/ Beading and Metalsmithing



How did I get trained in art: I was raised in Michigan and my mother was always involved in art of some type, including clothing design, floral design, jewelry and quilting. I fell in love with jewelry when my grandmother gave me her set of Mikimoto pearls, that my father had bought in Japan in the 1950's. My college education was first in clothing and interior design, moving soon to architecture. My first job after college was in structural steel space frame design.

I eventually moved to education after the travel of the architectural scene became too much with small children at

home. My husband and I have been collectors of art for 40 years.

After my mother's death 6 years ago, I "inherited" her jewelry making supplies. My cousin gave me a lesson in beading and I was on the move. Since then I have taken classes at CreativeU, Harold Studio and from Jen Hanscom, supplementing by a lot of experimentation on my own. A number of special designs have occurred not because I knew how, but because I didn't know I couldn't.

Why do I use the medium I do: I work in a variety of mediums, including many types of beading and metalsmithing techniques in my work. Lately I have experimented with a wide variety of patinas, both on copper and sterling silver. Semi-precious gemstones and pearls are always included. I've never met a rock I didn't like!



What about the style: I like the feel of raw stones together with the elegance of pearls. I try to make things that are wearable in many ways and timeless, not fads. For example, my "pearl drops" can be worn with jeans

and a t-shirt or an elegant dress. In addition, I have incorporated gemstones into tableware, calling it "table jewelry". I cut and polish stones for wine stoppers and cabinet knobs. I am constantly refining my sterling "sculpture" series, finding new shapes to create.



Who were my great inspirations/artists/styles I admire: In addition to my mother, my grandmother introduced me to quality design in clothing and food. Later, I worked for Louis Redstone, a regionally well-known architect and artist in Detroit. Louis introduced me to abstract watercolor, a medium I had not enjoyed before. *Jeweled Serving Pieces*



Where did I go to school: I have a BS in Architecture from the University of Michigan, a minor in Marketing and Graduate Certificate in Historic Preservation from Eastern Michigan University. I have an

MA in Curriculum from Chapman University.



Many important Issues before council this Monday. This meeting experiments with a new, untried legal structure that is funded by raising private construction cash with bonds, with minimal town review.

Questions for the Council regarding Cahava Springs – Agenda Item for Monday Council Meeting



We have printed and read thousands of pages of information from Arizona statutes and Maricopa county records. Boiled down, here is what we would like the readers to be watchful of:

1. We have been told by Mr. Stapp and his lawyers that there is NO risk to the Cave Creek residents in authorizing creation of their independent town within Our town, governed by the new owners. We have been told that if their project fails, the Town/Residents will NOT bear any of the resulting costs.

2. At recent Town Hall Meetings, when asked specifically and separately by two citizens, Mr. Stapp affirmed that there was NO debt on the affected properties. Just some routine cash for costs.

3. Our Research Team discovered the existence of a NEW fourteen million loan recently filed against the affected property. That's \$14,000,000. Mr. Stapp knew that when he made his statements to the full room of town citizens on April 28th.

4. Mr. Stapp confirmed on multiple appearances that "they" had \$5 million already invested in the project.

So, here is what we DON'T know:

- Did Mr. Stapp and his lawyers misrepresent to the public and our Councilmen about the costs that must be recovered before a spade of soil is raised?
- If the \$14 million is working lines of credit, evidently qualified for, why do they need to encumber part of Cave Creek land?
- Equally important, it raises the issue of financial solidity. Is the \$14,000,000 already spent or is it funds available for the project? Or is it all invested in available land/lots?
- Has the Council been provided with full financials, and if so, who has reviewed these?
- Are all of the new LLC "partners" a way to screen from the Cave Creek public the fact that apparently the \$17,820,000 loan was refinanced and presumably became the 14,000,000 loan, and was long ago consumed. It <u>could</u> imply that little, if any, equity would be remaining toward "shovel ready" projects, like the water pipe to the west side. Again, financial records would answer that. The point is whether the builder/project is financially feasible for any level of completion. Or will we be stuck with an unfinished project/water pipes to west?
- What portion of expense for the pipe to the west side will be paid by Cave Creek vs. what Cahava will cover?
- Are we going to see any genuine financial reports before this deal is inked?

The Council needs answers to these and more, before signing acceptance, for their own peace of mind. Why is this important? If this expensive experiment fails, we will surely see a property tax in Cave Creek.

JANELLE SMITH- HAFF New Information about Parties to the Revitalization District

Cave Creek's on-line newspaper, Desert Foothills Chronicle, has revealed the existence of a FOURTEEN MILLION dollar Note against the proposed Cahava Springs Revitalization District property. Further Due Diligence reveals that, in 2007, the Federal Reserve Bank took action against Marshall BankFirst Corp. and BANKFIRST to "address weakness in asset quality, credit administration, management, and risk management identified by the Federal Reserve Board of Minneapolis." The Chairman of the Board and CEO for both of the institutions that the Federal Reserve Board took action against is Dennis M. Mathisen. Dennis M. Mathisen is also a Director for two of the three corporate entities that are petitioning for approval of the proposed Cahava Springs Revitalization District.

According to the Minneapolis "Star Tribune" newspaper: "In all, about 30 community banks from **Arizona** to Wisconsin took a hit on the fiasco." "One veteran banker close to the situation likened Marshall to a contagious cancer." "It might take three years to kill you. It's cancer, but you got the cancer from Marshall Group." "... it was lawyer-turned-financier Denny Mathisen who gave rise to BankFirst the loan syndicating machine."

The creation of a town within our town and approval of Cahava Springs Revitalization District will include turning governance of Cahava Springs Revitalization District over to Dennis Mathisen.

Approval of the Cahava Spring Revitalization District petition will affect our town -- forever -- in ways that will be, but have not yet all been, disclosed. As further due diligence is gathered it will be reported.

Will the mayor and members of town council approve the Cahava Springs Revitalization District at tomorrow night's town council meeting? Your attendance at the town council meeting is crucial to help convince our mayor and town council members to vote NO on the Revitalization District matter. Our thoughts matter and the mayor and town council members need to hear your thoughts and concerns. It's not too late to make a difference in the council's decision.
